<p><b>Choose ONE question from the following TWO questions and answer in a nominal word count of 2,500 words:</b></p> <p><b>Question 1:</b></p> <p>The company has decided to recruit new talent, in view of the business expansion.</p> <ol style="list-style-type: none"> <li>a) What should one bear in mind from an employment view perspective when recruiting new individuals? Give an overview.</li> <li>b) What should the privacy notice to be given to job applicants include, for it to be in line with the requirements data privacy legislation? Include all 6 mandatory information as well as 4 of the “if applicable” information and explain in brief what the information should be about in each.</li> </ol> <p><b>Question 2:</b></p> <p>A software development company (InvSoft Limited) has been engaged by a client (CliCo Limited) to supply an inventory management software for a value of €1.2 million, involving several project deliverables over 18 months, with staggered payment. Half way through the project, CliCo Limited stopped paying the payments within the stipulated due dates.</p> <ol style="list-style-type: none"> <li>a) Outline the various elements of the document to be signed by the parties, and any specific clauses which need to be included. Take into consideration that COVID restrictions are still in place, and that in person signing might be restricted.</li> <li>b) Outline the remedies available to InvSoft Limited to obtain redress against CliCo Limited, and obtain payment.</li> </ol>
